# IPM Program (Pest Management) - Koenes

- Updating for summer, ants and bees; bees have already showed up on campus. Anticipating an active bee season. We try to have them removed and taken to North County if at all possible but at times, depending on location and circumstance they need to be exterminated. Recently had situation where swarm was right where students would walk and made their way into the building through the conduit so they had to be exterminated.
- Ants: Typically do not spray interior of buildings, only as a last resort. Asking that staff keep common areas
  clean of food/crumbs/spills as even as little as a dried drip of coffee will bring in the ants; this request includes
  desks and drawers.
- Custodial staff does not clean desks or move items on desks; they also do not clean breakrooms so please ask staff to be vigilant in keeping the areas clean to avoid an infestation.
- We will do exterior treatments for pests so please alert us if you experience issues. Someone from Facilities Management/Grounds will inspect to see which course of action can be taken to eliminate the problem.
