- B. Resolution to accept the definition of Distance Learning developed by the Vice Presidents' Council. There was lengthy discussion concerning this document. Questions, comments, and concerns, included a need for clearer definitions of Telecourses, Telecommuting, and

Internet access. It was also noted that downlink ability for teleconferences is available at both colleges, not just Cuyamaca. There were enough questions raised that the senate request that the Vice Presidents come to a future Senate Meeting. The SOC will work with the Cuyamaca SOC and the Vice Presidents to see if this is feasible for the joint Senate Meeting in the fall.

D. Resolution to approve the following no smoking policy to be adopted by the Governing Board

"It shall be the policy of the Grossmont-Cuyamaca College District to prohibit smoking in all district buildings; within twenty-feet of the entrance of any district building and in the physical education and athletic areas of the campuses."

The resolution was passed with the suggestion of amending "within twenty-feet of the entrance of any district building" to read "within twenty-feet of any entrance to any district building" M/S/U Winn, Hubbard

1) A document for Articulation Alignment and Differentiation will be presented at the joint Senate meeting in the fall.

2) Reminder: The Content Reviews, for prerequisite validations, are going into the catalog by July 1, 1998. The Content Reviews need to be submitted to the Curriculum Committee by August 1997, or they will be removed from the catalog.
