II. **PRESIDENT'S REPORT:** (Monica)

III. IEPI VISIT: (Bryan)

IEPI team came December 6th, 2017. This was the second visit to our campus. The first visit on October 4, 2017 was to get to know Grossmont College and learn what our three goals (ISLO's, governance and resource allocation) for accreditation are. This visit we were told that we have some serious issues that could result in sanctions. Transparency was one issue –The team had a difficulty locating information on our website like the Governance structures. The Website needs to be fixed. They also indicated that ISLO's and resource allocation need to be tied together. IEPI handout is a response by the College to improve these items. \$200,000 grant will be available to make appropriate improvements in the areas of Governance Structure, ISLOs, and resource allocation that may include technical support in software or technical assistance with consultants.

Accreditation standard II: student learning programs and services and standard IV: leadership and governance are the areas of focus.

Elaine to ask Denise Schulmyer when ISLO's are officially approved and when we will start using them.

Discussion about using the newsletter and website for initiatives on campus –Achieving the Dream, Accreditation and Guided Pathways. Discussion of the importance of educating classified staff about accreditation and how this could be done via the newsletter. It was suggested that Accreditation chairs be interviewed for articles for use in the newsletter.
