# **OPENING INTRODUCTION AND SUMMARY BRIEFING:**

The committee went through a full introduction of existing and new members.

# **CONSTRUCTION PROJECTS UPDATES:**

# KI Furniture Roadshow:

The committee discussed the KI Roadshow to introduce new products to the college. The Facilities Committee and the Arts and Communications Task Force were invited.

# Signage for Track:

The committee discussed a recent request from a local community member for lighting on the track prior to sunrise. The committee agreed the track should not be used from the time the campus closes to the time it opens but what if it is still dark out. The committee discussed the need for signage to address this issue. The appropriate verbiage needs to prepared and vetted for approval.

# Landscape Upgrade Phase I (in-house photos):

The committee discussed the first re-landscaping project which has been completed at the front of campus by Jack Newman. Further projects will be presented to the committed. MTS Bus Stop, Walkway to Lot #5, Monument Directories and patio areas are forthcoming.

# **Pool Equipment Replacement Project:**

The committee discussed the Bid opening that took place on March 31<sup>st</sup>. The project came in under budget by \$25,000. Notification to the public will be posted within a week at the pool stating it is closed for the summer and due to re-open mid-August 2015.

# **ACE Swing Space:**

The committee discussed the swing space relocation for ACE during the reconstruction of the parking lot 2, 3, 4, and 4A this summer. ACE will be relocated to swing space in Building 21offices 256, 257, and 259.

# Campus Wide Signage Phase III:

The committee discussed the Campus Wide Signage Phase III which Gafcon will manage. This project is to include signage for 200, 300, and 500 Complex offices with braille and name slip-in signage. Di Donato, Architect will perform and review inventory of needed campus signage. The committee noted a change for parking lot 7 to parking lot 1 is needed on existing directories.

# **Campus Pay Phone:**

The committee discussed the request from a student through ASGC for a pay phone. The college removed all pay phones on campus based on lack of use over ten years ago. The committee agreed there was not a serious need to bring this service back to the campus. The committee suggested a designated area for emergency use for phone calls. Ken will bring a proposed area back to the committee.

# **Library Lounge:**

The committee discussed the new Library Lounge in the LTRC. There will be several bookcases removed and (5) new lounge areas created for students. There will be (4) privacy sound absorbing booths for cell phone conversations. A Task Force of the users in the LTRC was assembled and after several meetings the task force agreed on the furniture style, fabric colors and patterns. The new furniture fabric is heavy duty vinyl, easy to clean and very durable for heavy usage.

# **Volleyball Courts Project:**

The committee discussed the new volleyball courts project being almost complete. This project needed additional sand due to compaction and new materials will be delivered in (2) weeks to level out of the sand. The committee requested an email to notify that area not to be blocked during project excavation of sand.

# **Skateboard Stoppers:**

The committee discussed the skateboards stopper. The committee agreed there was a need to have the assets protected. Ken will contact Nicole regarding vandalism and non-student skateboards.

The Committee members requested cameras for asset protection and vandalism prevention. Randy Clark will bring the request to District.

# **Building #43 Mural Project:**

The committee discussed a prosed mural on Building 43. The project will require further discussion but the concept of visual timeline using ceramic times was a good suggestion. There will be the need for a few departments to meet and determine what the scope would include and how to get the project moving.

# **Outreach Events**


The District hosted events on March 16 at Grossmont College and March 18 at Cuyamaca College for small, underutilized, and local firms as part of its Outreach Program to include these businesses in District bidding opportunities. Contractors were given an overview of upcoming projects, the schedule for bids on summer projects, and a brief presentation on the first two major capital improvement

projects: Grossmont College
Arts and Communications
Complex and Cuyamaca College
Student Services Center.
They were also informed of a
new contractor registration
requirement that went into
effect in April 2015, based on
legislation that went into effect
in June 2014.

Thirty-two people attended the events from 25 different firms. Eight firms were present at both

events, plus an additional 13 at Grossmont College, and four at Cuyamaca College.

Of the 25 firms represented at the events, all but one has businesses located in San Diego County, four of which are East County firms located within the District's boundaries. Nineteen of the firms are certified small/underutilized businesses and all certification types were represented at the events.



# **Bid Openings**

# Cuyamaca College Weight Training Classroom

Cuyamaca College's Weight Training Classroom project includes installation of a new 36' by 40' modular building adjacent to the campus gym for instructional use. Three firms submitted bids for the project on April 7. All are verified small/underutilized businesses with two located in San Diego County, including one within the District's boundaries.

The bids are currently being reviewed and the contract is expected to be awarded in late April.




# Grossmont College Pool Equipment Replacement

The bid opening for the Grossmont College Pool Equipment Replacement was held March 31 and three bids were received. Two of the firms are certified small/underutilized businesses and one is located in East County. Due diligence on the apparent low bidder is in progress.

Project construction includes removal and replacement of existing mechanical equipment and partial pool deck renovation.

# Grossmont College Parking Lot/Roadway Repairs

Work for the Grossmont College Parking Lot/Roadway Repair project includes the repair or replacement of five Grossmont College parking lots. Six firms submitted bids on April 7. Half of the businesses are small/underutilized businesses, and all are local. The bids are being reviewed and a contract is expected to be awarded in late April. Construction will occur during summer break.

# Cuyamaca College Parking Lot/Roadway Repairs

Construction on Cuyamaca College pavement includes the repair of one parking lot and two roads. The bid opening for this project is April 16. The mandatory pre-bid meeting was held on March 26 with 16 contractors in attendance.







# Drought Tolerant Landscaping - Informational Signs

The four Innovator of the Year award-winning drought tolerant gardens at Grossmont College received 147 small identification signs to provide information on individual native plant types within each garden. The small signs list the plant genus, species, and family.

Additionally, larger landscape-area interpretive signs will be installed this summer. The signs will note the name of the garden, the type of climate in which the plants grow, and areas around the globe to which these plants are native. College faculty is currently advising specifications.
